

CODE OF CONDUCT AND ETHICS – International Pairs Festival of Golf, Dubai

Golf is a sport that requires high standards of behaviour and sportsmanship and relies heavily on honesty, integrity, and self-regulation.

Participants are therefore expected to bear this in mind when considering their approach both on and off the golf course.

Please note that International Pairs, GolfTraveller and representatives will not be held accountable for the following pre, during and after the Festival of Golf event:

1. Loss of personal items.
2. Injury or harm to self and others.
3. Any personal outstanding accounts, credits while at the event, at the hotels or courses.
4. Any medical or hospital bills and accounts.
5. Any fees that might incur due to breakage, damage or loss of hotel, golf course, and organizers equipment.
6. Any lawless activities and implications that follow.
7. Cancellation of travel due to any reason and the fees that might incur. (Excluding Covid related travel restrictions by country laws)
8. Loss of baggage.

By Entering the Festival of Golf Event you Acknowledge the following:

1. You agree to the rules and regulations of the event.
2. You agree that your handicap is true and proof thereof will be required before the start of the first round. If any handicap manipulation is found, the player will be disqualified from the event and any losses is for the players own account.
3. You agree to abide by the rules of golf set by R&A and any penalties that might incur during the event.
4. Any outstanding accounts at the hotel, restaurants and golf courses be settled before leaving.
5. Acknowledge diversity and respect other cultures and beliefs.
6. Acknowledge the protocol of other countries.
7. Acknowledge the protocol of the Sponsors.
8. All costs incurred by International Pairs or GolfTraveller and the Sponsors on the participant and his/her partners behalf will be recovered from the transgressing participant.
9. Any damage to property caused will be recovered from the participant.
10. Tournament Organisers and Representatives can change and amend any tournament regulations if they feel this is in the best interest of players participating and the event itself.
11. Decisions made by tournament organisers are final and will not be looked into further once implemented.
12. Refunds of entries not related to Covid 19 Laws will not be permitted.

13. Photographs. By entering the tournament, you hereby grant the tournament organisers and media parties involved the irrevocable right and permission to photograph or videotape (or to use any similar medium) to record yourself and others involved identified below, for all purposes, including advertising and promotional purposes, in any manner without any further approval and without payment. By entering the tournament players understand that any and all photographs, motion pictures, video recordings, and/or likenesses of me captured during any Airtime Activity, its affiliated entities or contractors, and/or the media become the sole property of the tournament organisers and media parties involved. Players hereby grant the right, permission and authority to tournament organisers and media parties to use and license others to use your name and any such photographs, motion pictures, recordings, and/or likenesses (the "Recordings") in any manner. The Tournament Organisers and media involved wishes and in any and all media now known or hereafter discovered or developed, in perpetuity, without geographical limitation, including but not limited to promoting, advertising, and marketing activities. Players further understand that the tournament organisers and media, as sole owner of the Recordings, has the full right to sell and/or profit from the commercial use of such Recordings or to transfer or assign the rights to use such Recordings to any entity without restriction. Players hereby agree not to sue and irrevocably and unconditionally release, waive and forever discharge the tournament organisers and media Released Parties, together with any commercial television or media company, and their respective past, present and future parents, subsidiaries (whether or not wholly-owned), affiliates, divisions, agents, representatives, employees, successors and assigns, jointly and individually, from any and all manner of liabilities, claims and demands of any kind or nature, whatsoever, in law or equity, whether known or unknown, which I (or my assigns, agents and/or representatives) ever had, now has, or in the future may have against the tournament organisers and media Released Parties.
